5 scholarship, the Authority shall ensure that the student's continuing eligibility is assessed at least
6 every three years by one of the following:

7 (1) The local educational agency. – The local school educational agency shall
8 assess if the child continues to be a child with a disability and verify the
9 outcome on a form to be provided to the Authority.

10 (2) A licensed psychologist with a school psychology ~~focus~~ focus or psychiatrist. –
11 The psychologist or psychiatrist shall assess, after review of appropriate
12 medical and educational records, if the education and related services received
13 by the student in the nonpublic school setting have improved the child's
14 educational performance and if the student would continue to benefit from
15 placement in the nonpublic school setting. The psychologist or psychiatrist shall
16 verify the outcome of the assessment on a form to be provided to the
17 Authority."
