To provide food service to children from needy areas during periods when area schools are closed for vacation.

NC Division of Public Health Summer Food Service Program Sponsor

A sponsor is a public or private nonprofit agency which is approved to receive reimbursement for serving meals to eligible children in the Summer Food Service Program

Children 18 years old and younger and persons who are determined to have mental or physical disabilities and who still participate in an educational program during the regular school year.

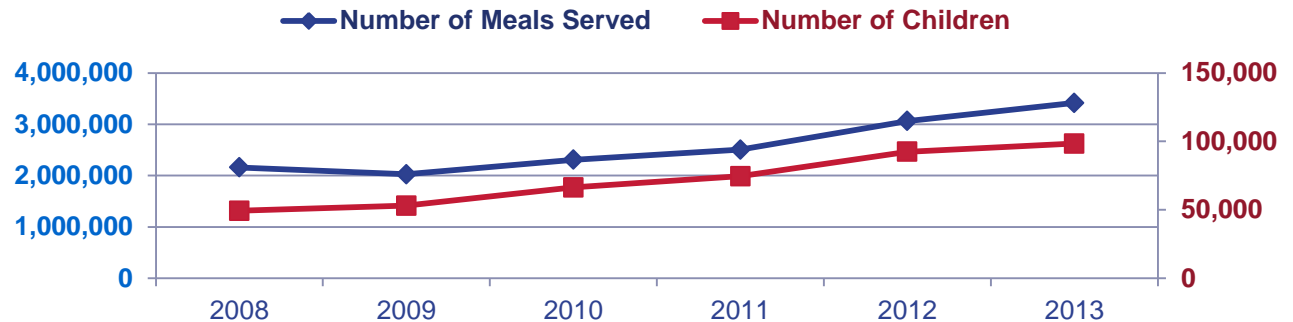
