19 Notwithstanding G.S. 14-415.11(c), any of the following persons who has a concealed
20 handgun permit issued pursuant to this Article or that is considered valid under G.S. 14-415.24
21 is not subject to the area prohibitions set out in G.S. 14-415.11(c) and may carry a concealed
22 handgun in the areas listed in G.S. 14-415.11(c) unless otherwise prohibited by federal law:

24 (10) For only a law enforcement facility covered under G.S. 14-415.11(c)(5), a
25 person employed by a law enforcement agency who (i) is not a law
26 enforcement officer sworn and certified pursuant to Article 1 of Chapter 17C
27 or 17E of the General Statutes, (ii) has been designated in writing by the head
28 of the law enforcement agency in charge of the facility, (iii) has in the person's
29 possession written proof of the designation, and (iv) has not had the
30 designation rescinded by the head of the law enforcement agency in charge of
31 the facility. Nothing in this subdivision shall be construed as prohibiting the
