\$1,239,386 as of February 26, 2013
- 2. What is the breakdown of FTE in SBI Administration?**

- 3. How much is collected by the illicit drug tax?**
\$8.3 million was collected in FY 2010-11. Please see attached information sheet (last page) from the Department of Revenue for details.

- 5. Can we get a 5-year turnover history for the SBI by position type?**
