DATE	FACILITY NAME	FACILITY SUSPENSION/MODIFICATION
1/1/2017	Warren Correctional Institution	88 beds were suspended due to staffing deficiencies.
5/1/2018	Polk Correctional Institution	120 Offender Beds were eliminated due to staff deficiencies.
6/24/2019	Robeson CRV	Suspended Operations due to staffing deficiencies. Facility had 192 offender capacity. At time of suspension facility had 120 offenders and 60 staff. 71 staff positions were assigned to this facility.
7/1/2019	Anson Correctional Institution	A 20 bed restrictive housing minimum custody unit re-opened due to Lanesboro being converted to a female housing facility.
9/1/2019	Polk Correctional Institution	120 additional Offender beds were eliminated due to staffing deficiencies.
9/20/2019	Craggy Correctional Institution	Building 3 suspended operations due to staffing deficiencies. 134 offenders were shipped out. 8 staff were assigned to run the unit that was suspended.
10/8/2019	Hoke Correctional Institution	504 beds went offline from D, E, and F, pods due to Anson becoming a female unit.
12/1/2019	Odom Correctional Institution	352 beds went offline and operations suspended due to staffing deficiencies.
1/6/2020	Tyrrell Prison Work Farm	Operations suspended staffing deficiencies. Facility had 77 of 151 positions filled at time of suspension. Employed staff were assigned to other facilities that had staffing needs. This facility had capacity for housing 620 offenders.
4/16/2020	Burke CRV	Suspended operations, Covid/staffing deficiencies. Staffed for 47 certified, 8 Probation Parole Officers, 6 Administrative Staff. Facility has 248 bed capacity. Employed staff were assigned to new locations to assist with staffing needs.
7/10/2020	Burke CRV	On 4/23/20 Offenders from Johnston Correctional Institution were temporarily moved to Burke CRV because of Covid/staffing deficiencies and moved back in July returning the facility to suspended operations.
8/5/2020	Tyrrell Prison Work Farm	Re-opened with limited capacity. Currently 64 staff are assigned to the facility with 31 being Correctional Officers. Currently housing 180 offenders.
8/10/2020	Pasquotank Correctional Institution	272 beds went offline from Minimum Unit due to staffing deficiencies.
10/26/2020	Robeson CRV	Re-opened after hiring enough staff to become operational. Currently facility has 75 offenders and 71 staff.
11/1/2020	Burke CRV	Began hiring staff to tentatively prepare for reopening the CRV in March of 2021. Staffing pattern remains the same 47 certified staff, 6 Administrative staff 8 Probation Parole Officers. 248 bed capacity. Scheduled to begin housing offenders in March 2021.

11/20/2020	Randolph Correctional Center	Temporary suspended to supervise secure wing - operations at Kindred Hospital. Reduced offender population to 75 with 64 staff.
11/20/2020	Southern Correctional Institution	Temporarily suspended at minimum custody unit, enabling staff there to better assist in other sections of the prison.
11/25/2020	Piedmont Correctional Institution	Suspended minimum custody. Reduction in number of minimum custody offenders, Covid/staffing deficiencies. Employed staff was re-assigned to other facilities to assist with staffing needs.
12/8/2020	Mountain View Correctional Institution	Went to modified housing with restricted movement due to staff deficiencies. This was temporary during their COVID outbreak with staff and offenders.
12/8/2020	Marion Correctional Institution	Suspended minimum custody unit. Covid/Staff deficiencies. Employed staff reassigned to Close Custody facility to assist with staffing needs. This unit housed 102 offenders and had 20 assigned staff for normal operations.
1/1/2021	Mountain View Correctional Institution	The facility went from double cell to single cell. Staffing deficiencies. This reduced offender population from 908 to 576. This move was more operational safety to bring inmate to staff ratio into safe manageable operation. Reduction to single cell began in earlier in 2020.
1/28/2021	Craggy Correctional Institution	Building 3 re-opened with Marion Correctional Institution and other facilities staff assigned on rotation to assist with staff deficiencies.
2/12/2021	Avery Mitchell Correctional Institution	Suspended one wing due to Covid/staffing deficiencies. 134 offenders can be housed on the wing. Normal operations require 12 Officers to run that wing.
