

Wildlife Resources Commission Budget Vacancies Update March 28, 2013

The WRC initiated a comprehensive organizational review in June 2011. This is a top-to-bottom analysis of the agency's efficiency, effectiveness, and overall alignment of work with the goals of our strategic plan. In completing the first phase, the Commission reduced supervisory staff by 30 positions and reallocated those positions to the field. The organizational review is currently in its second phase which is focused on the functional areas of Conservation Science and Information & Education. The positions highlighted in yellow below remain vacant pending the outcome of the next phase of internal reorganization, scheduled for July 2013.
